## Guidelines for establishing membership dues to the North Dakota Petroleum Council.

While the guideline is the recommended means to calculate dues for a prospective member, the Board of Directors reserves the right to negotiate a different rate for any prospective member and may consider other factors, such as company size, number of offices, gross income, or any other factor the board deems appropriate for consideration. **This is a minimum suggested dues schedule. 10.5% of dues amount is lobbying expense and not deductible for tax purposes.**

### OIL AND GAS PRODUCERS

This category includes companies engaged in upstream activities. Membership dues are based on total production equal to the gross amount of oil produced (in barrels) plus gross gas production (in million cubic feet per day converted to crude barrel equivalent) between September 1 and August 31 each year as they are reported to and by the North Dakota Department of Mineral Resources.

### NDPC OIL AND GAS TRANSPORTATION OR PROCESSING

This membership includes companies engaged in the midstream activities of the oil and gas industry. Membership rates are based on the daily throughput of North Dakota crude oil and natural gas pipeline and natural gas processing systems. Crude oil transport is measured in barrels of oil per day and natural gas is measured in million cubic feet per day. If a company transports crude oil and natural gas, the throughput will be a combination of both commodities.
